AGM 20th NOVEMBER 2022 via ZOOM – DATE FOR YOUR DIARY

We propose to hold our 2022 AGM on **Sunday 20th November 2022** at 11am via the ZOOM platform, so please save the date.

It has been agreed that the 2022 AGM will provide all attendees with 1 hours CPD and a CPD certificate of attendance will be emailed to all members in attendance after the event.

FIRST AID REFRESHER COURSES – Attendance Based and Online courses

We have continued to monitor the availability of attendance based courses in recent months, taking into consideration the difficulties associated with running attendance based courses during the Covid –19 pandemic.



Following a review of providers meeting NARCH requirements, it would seem that attendance based first aid refresher courses are still in short supply, with some course providers offering online courses only. As a result, the Committee has agreed that until 1st October 2022, all NARCH members needing to refresh their First Aid training will be encouraged to try to find an attendance based course (that meets NARCH requirements)

wherever possible. However, should this not be possible, members may take an online course providing the course meets NARCH requirements and this will be irrespective of whether their previous refresher had been an attendance based course or an online course.

Please do visit the first aid guidance document held in the Resource Library of the NARCH website, which provides a list of attendance based and online first aid refresher course providers meeting NARCH requirements.

The NARCH Committee will revisit this matter on 1st October 2022 to determine whether our first aid refresher rules can revert to pre-Covid times.

CHANGES TO OUR MEMBERSHIP FEE INVOICING PROCEDURES

We have recently changed how subscriptions are to be paid to NARCH.

To clarify this, all members will now receive an automatically generated invoice 14 days prior to their own specific membership fee renewal date. It will now be the responsibility of members to pay this invoice, once it is received.

Please note, NARCH will no longer be taking automatic payments from a



members own PayPal Account. It is therefore important that all members make their membership fee renewal payment upon receipt of the automatically generated invoice, in order to ensure that their name remains active on the NARCH Register.

SOAP NOTES - What are they and what do they mean to YOU?

We have mentioned this regularly over the past 2 years in previous newsletters. From 1st April 2021 all patient treatment notes need to be written following the SOAP notes format which is used by the veterinary profession. Following this format will mean that all centres will be able to show clear clinical reasoning in their patient notes. SOAP is an acronym: S-Subjective, O-Objective, A-Analysis, P-Plan.

If you are unsure what this means for you and your centre then please review the



SOAP Presentation video (mp4 format) and the pdf document entitled "Presentation Slides for Note Taking" that you will find on the Resource Library.

All RCHs must be able to demonstrate that their patient treatment notes have been written following SOAP notes format. The NARCH Guide to Professional Conduct will be amended to include SOAP notes as a requirement for all RCH's. During the audit process, our auditors look at samples of your patient treatment notes, focusing on how these have been written. It is therefore really important that you ensure your patient notes follow the SOAP notes format.

CPD FOR 2022 - What does your NARCH CPD record look like?

It is now past the half way point in the year and by now you ought to have at least 10 hours CPD uploaded and validated to your NARCH record.

So, make sure that you are on track with your CPD plans for 2022 – you need to have 20 hours CPD approved and validated on your NARCH record before 31 st December 2022 in order to avoid temporary suspension from the NARCH register in the first week of the New Year. The Resource Library has a guidance note about CPD, so please take a look.

If you are a newly registered RCH during 2022, you will have already been advised regarding how many pro rata CPD hours you will need to complete by 31st December 2022. If you are in any doubt, please contact enquiries@narch.org.uk for assistance.



CPD FOR 2023 – PROPOSED CHANGES COMING INTO EFFECT ON 1ST JANUARY 2023



The Committee have carried out a thorough review of NARCH CPD rules and believe it is now appropriate for a change to be made to the total number of annual CPD hours required for all RCHs. The change will come into effect on 1st January 2023 and will mean that 25 hours, rather than the current 20 hours CPD, will need to be completed in each calendar year by all RCHs.

Within this new total of 25 hours, the number of uncertificated CPD hours will be limited to 15 hours, of which 5 hours only may be achieved through reading.

An explanatory email will be sent out to all RCHs in the near future explaining this change in detail and we will be updating the CPD Guidance Notes held on the Resource Library to reflect this change. The NARCH Guide to Professional Conduct will also be amended to include this change.
