

**TRAINING REQUIREMENTS FOR INCLUSION ON THE NARCH LIST OF
REGISTERED
CANINE HYDROTHERAPISTS**

Hydrotherapy Pool Use only:

If you will be providing hydrotherapy in a pool only, you will need to evidence at least **ONE** item/criteria from sections **A and B** in table 1.

Water Treadmill:

If you will be operating a water treadmill, you must have completed additional water treadmill training and evidence at least **ONE** item/criteria from each of sections **A, B, and C** in Table 1.

Please note most of the required water treadmill training is listed as units and may be offered in more than one qualification.

N.B. (1) If you operate a treadmill without the correct treadmill qualifications you will require supervision at all times by an RCH who has gained the requisite qualifications.

N.B. (2) Any ABC qualification attained prior to 1st September 2012 no longer satisfies NARCH training requirements for new registrations.

Returning to NARCH

Should an RCH allow their registration with NARCH to lapse/be cancelled/be suspended/be moved to pending re-certification for a period of 2 years or more, the following requirements will need to be evidenced to NARCH, before re-registration to NARCH will be granted:

- 10 hours proof of recent CPD training undertaken within the preceding 6-month period prior to application to re-register with NARCH

AND

- Returning after a 2 year break – 7 hours of practical training
- Returning after a 3 year break – 14 hours of practical training
- Returning after a 4 year break – 21 hours of practical training
- Returning after a 5 + year break – number of hours practical training will be individually assessed
- **ALL** practical training must be undertaken with a NARCH Approved Practical Training Assessor (NAPTA) or with a NARCH Approved Training Provider
